Recitals

Customer and Company desire to exchange advertising and links with lease agreements or addendum of lease agreements as set forth in this agreement.

Agreements

In consideration of the mutual covenants set forth in this Agreement, Company and Customer hereby agree as follows:

1. Advertising and Promotion.

The _____ apartment property(s) shall arrange for the placement of advertising and promotion of their property and agrees to fulfill the following duties:

- Give the Erie-Niagara Tobacco-Free Coalition a copy of their lease or addendum to a lease explicitly stating that no smoking is allowed in the (above) apartment property(s).
- Advertisements to be reimbursed must contain the words “NO SMOKING” concerning the property and/or have the international “NO SMOKING LOGO” present in the ad.
- The Customer agrees to obtain original receipts from the publication(s) of their choice and will submit those receipts to the Erie-Niagara Tobacco-Free Coalition for reimbursement.

2. Specification and Services Completion.

- “Advertisements” will encompass any material advertising of the specified property that contains the words “NO SMOKING” and/or has the international “NO SMOKING LOGO” present in the ad.
- The advertisement may be placed in the publication of the Customer’s choice.
- This contract for reimbursement is valid from one year of the signing of the agreement.

3. Compensation.

- The **Erie-Niagara Tobacco-Free Coalition** agrees to reimburse the cost of the advertising of the smoke-free property listed on submitted receipts as follows:
 - Per housing development with 2 units - \$200
 - Per housing development with 3 units - \$300
 - Per housing development with 4 units - \$400
 - Per housing development with 5 or more units - \$500

MAXIMUM of \$500.00 per owner.

Contract valid up to one year from the signing of this agreement.

- The **Erie-Niagara Tobacco-Free Coalition** agrees to supply “No Smoking” signage to the landlord for posting in and around the property(s) for which this agreement has been made.
- The **Erie-Niagara Tobacco-Free Coalition** is intent on letting Erie and Niagara county residents know that smoke-free housing exists and agrees to promote the above apartment property on the Coalition’s smoke-free dwelling website: www.smokefreehome.org, when the Customer subscribes to RentLinx.
